**ON-GOING PROJECTS**

The Board have a long 'wish list' of proposed projects to update and improve the buildings and grounds; however these works are always subject to available funds and therefore have to be prioritised accordingly. The main focus points in the coming twelve months are as follows:

**Balconies:** Unfortunately the decorator sustained an injury that has slowed the progress of this project that was due to complete this year. With the change in weather, the work for 2017 has come to an end, however the project will pick up again in Spring and all those whose balconies are yet to be painted will be contacted for access and the work will complete in 2018.

**Bin Stores:** Consideration of the re-modelling of the bin-stores is on-going .

**Building Entrances:** Consideration is being given to how the front entrances can be improved by redecorating the entrance doors and surrounds and installing new outside lights and planters.

**CCTV** – The Installation of CCTV to monitor the front gates has been provisionally agreed, subject to costs. Further details will be provided in due course.

**Windows** – The timber windows within the common parts are replaced for new upvc. It is anticipated that the project will take place in January 2018. The exact date, once known, will be communicated to all residents.

**REMINDER FOR ALL RESIDENTS**

We cannot stress enough that children shouldn't be left to play unsupervised in the communal areas and ball games are not permitted; furthermore children should never be allowed to play in the access roads. This is dangerous and we are concerned that there will be an accident. Drivers are reminded to drive at a low speed whilst on the grounds. Dogs are not permitted.

In the interests of good neighbourly relations, no unauthorised social gatherings are permitted to take place within the grounds.

One final reminder also that no washing or any household items are permitted to be left on the balconies.

We hope that by now you will be enjoying clean bright shiny windows The same contractor was used as on previous occasions and to date all residents have been happy, however do let us know if you have had any problems during this cleaning cycle. The next window clean is scheduled for April 2018 and the exact date will be communicated nearer the time.
