Description

Trinity Court is a modern open plan office building located in the heart of Rickmansworth split over three floors. Situated on the Grand Union Canal and opposite the Rickmansworth Aquadrome, Trinity Court offers a picturesque and tranquil work environment with excellent connectivity and local amenities.

The offices have been finished to a high standard and get large amounts of natural light. Space is available from 549 sqft on the first floor, 2,500 sqft on the second floor and the ground floor is available as a whole.

Location

Trinity Court is just a short walk from Rickmansworth Station which provides a fast and regular service to Central London via both underground (Met Line) and rail (Marylebone). Rickmansworth is a particularly attractive town with a wide range of amenities.

Rickmansworth is situated approximately 20 miles to the north west of Central London some 2 miles from Junctions 17 and 18 of the M25, benefitting from excellent access to the regional motorway network (M1, M40 and M4).

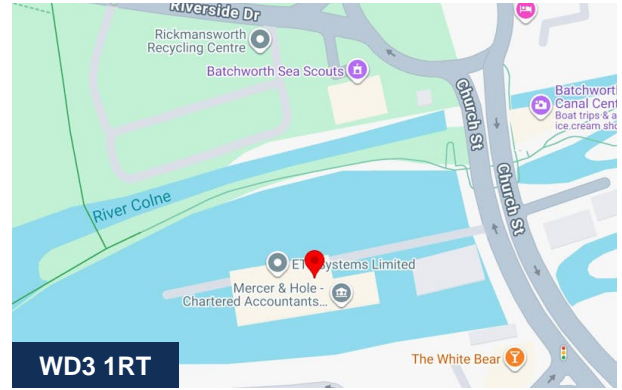
